### Sustainability and agrifood systems transformation: FAO Regional Conference for Europe



The Rome based Food and Agricultural Organization (FAO) organized a private sector dialogue session in preparation for its Regional Conference mid-May in Rome, on the implementation of

climate resilient and low-emission pathways in agrifood systems.

EDA secretary general **Alexander Anton**, one of the invited panellists, highlighted in his speech:

"FAO has identified the agrifood transformation as a crucial theme of the UN Agenda 2030 – we as European lactosphère are redefining our dairy sustainability agenda 2030 right now: the dairy sector is instrumental in driving climate smart innovation in dairy farming and processing. We value the open and bottom-up approach of FAO in setting up its work priorities in Europe very, very much."

## EDA voices dairy industry concerns on Nutri-Score at the Belgian EU Presidency

On 25 April, the Belgian Presidency of the Council of the European Union hosted a conference on 'Sharing experiences and perspectives on Nutri-Score and other front-of-pack nutrition labelling systems'. Her Majesty Mathilde Queen of the Belgians as well as the Belgian Deputy Prime Minister and Federal Minister of Public Health, Frank Vandenbroucke, opened the conference with 180 participants joining in person and over 250 online in order to exchange on Nutri-Score and other front-of-pack nutrition labelling schemes.

Prof. Serge Hercberg (University of Sorbonne) and Kremlin Wickramasinghe (WHO Regional Office for Europe) set the scene, and scientific research supporting Nutri-Score was presented by loanna Bakogianni (Joint Research Centre), Stefanie Vandevijvere (Sciensano, Belgium) and Pauline **Ducrot** (Santé Publique France). The national experiences on nutrition labelling were presented by Finland (Minna Huttunen and Sebastian Hielm of Ministry of Agriculture) and Portugal (Maria João Gregório, National Healthy Eating Promotion Programme). The Swedish Food Agency (Irene Blom) presented the Keyhole logo used in Sweden and Denmark since 1989. The use of Nutri-Score as a potential tool in prevention of non-communicable diseases was presented by the Norwegian Institute of Public Health (Knut-Inge Klepp). Hélène Alexiou (Belgian member of the Scientific Committee of Nutri-Score) presented Nutri-Score as a screening tool to regulate food marketing to children.

The event was concluded by a roundtable discussion with participation of Roser Domenech Amado (DG SANTE, EU Commission), Michele Cecchini (OECD), Emma Calvert (BEUC), Samuele Tonello (EuroHealthNet), Chantal Julia (University Paris XIII-INSERM), Els Bedert (Eurocommerce). Kinga Adamaszwili (EDA) represented the food business stakeholders.



In the panel, she highlighted that our support for the consumer's right to be fully informed on nutritional properties of foods.

She agreed that voluntary labelling schemes can be a useful tool for consumers who are looking for additional nutritional information on food labels, but only if it helps consumers to make healthier choices and follow dietary guidelines. Unfortunately, Nutri-Score and its new algorithm is still not fit for purpose:

"Almost all European cheeses score D, without much differentiation within the cheese category and regardless of their fat or salt content. What is more, the new Nutri-Score algorithm degraded nutritional rating and image of milk: skimmed and semi-skimmed milk is now rated B (downgrade from A) and whole milk is now rated as C (downgrade from B). This negative Nutri-Score message is not only confusing and contradictory to dietary quidelines but could discourage consumers from consuming milk, cheese and other dairy products, potentially leading to important nutrient deficiencies and further public health consequences. Milk and dairy, including cheeses, thanks to their natural nutrient richness, are recommended to be consumed daily by all health authorities across the EU. Milk and dairy are the leading contributors to calcium, iodine and vitamins B intake as well as high quality milk proteins in the EU populations." She concluded that "The current system needs urgent adaptation in order to be more useful to consumers and aligned with dietary quidelines to reflect the nutritional quality of dairy products".



## EDA/EWPA webinar on semicarbazides on 15 May

On 15 May, EWPA/EDA will host its webinar 'Semicarbazide in dairy ingredients - EWPA/EDA work towards a better regulatory solution and achieving best practices in the dairy industry'. The webinar will inform participants about the 2-year project carried out by the European Whey Processors Association (EWPA) and the European Dairy Association (EDA) on the regulatory challenge of limiting semicarbazide (SEM) in dairy ingredients. Thanks to the EWPA/EDA dedicated SEM Task Force led by Christian Bruun Kastrup (Danish Dairy Board) and composed of experts from EWPA member companies, in March 2024, the EU Commission and Member States granted a legal exemption to dairy ingredients. The work of the task force, its impact on the dairy industry, and next steps will be presented by Prof. Thom Huppertz, who is a key member of the EWPA/EDA SEM Task Force.

## EDA joins afgrifood sector in advocating for promotion policy

In a joint letter with other agri-food sector associations, EDA recently voiced its concerns regarding the potential impact of budget reallocations on the European Union's Promotion Policy.

The text addresses shared concerns within agri-food sector associations regarding the European Council's decision to redirect €1.1 billion from the Common Agricultural Policy and Cohesion policy to support Ukraine. While awaiting clarification on the budget allocated to the Directorate-General for Agriculture and Rural Development, there are worries that the financing of the 2025-2027 Annual Work Programmes will be affected.

The importance of promotion policy funding in maintaining market competitiveness, especially in light

of COVID-19 and other challenges is widely recognised by stakeholders, who advocate for maintaining previous budget allocations. EDA, therefore, calls for continued collaboration between industry stakeholders and

industry stakeholders and policymakers to ensure the EU's Promotion Policy's success in boosting the competitiveness of EU agricultural products.
